PART B - PRIVACY

- The Winner acknowledges and agrees that the Promoter may publish or cause to be published the Winner's name and locality in any media as required.
- If a Winner accepts the applicable Prize, the Winner agrees to participate in all reasonable promoted activities in relation to the Promotion as requested by the Promoter, and the Promoter reserves the right to use the Winner's name and photograph

for marketing and publicity purposes in any media for an unlimited period without remuneration or compensation.

PART C - WHO CAN ENTER THE COMPETITION

11. Entry is only available to residents of Australia aged 18 years of age or older (participant) are eligible for the Competition.
12. The following person(s) are ineligible to enter the Competition:
 - (a) employees of:
 - (i) the Participating Retailer (as defined in paragraph 3 below) within the Participating Centre
 - (ii) the Promoter;

13.
